## I. Call to Order

Mr. Lisi called the meeting to order at 10:46 a.m.

#### II. Approval of Minutes:

A motion was made by Mr. Barnes and seconded by Mr. Foster that the Board of Directors of the Connecticut Student Loan Foundation approves the minutes of the November 10, 2021 meeting, pending a correction on page 3 that erroneously listed Mr. Kitowicz as the second motion to approve the 2022 meeting dates. The motion passed unanimously.

## III. Contribution to CHESLA Refi CT Program

Ms. Weldon indicated that this resolution acts in conjunction with a previously approved motion at the earlier CHESLA meeting, which pertains to an additional release of funds from the CSLF trust for CHESLA ReFI program. Mr. Webb detailed how they researched the impact of this transaction on the overall portfolio using a cash flow analysis like that of prior years. They found that given the expected trust performance, under the analysis' assumptions, an additional \$2.0 million cash release should not have a significant impact. However, Mr. Webb noted that this release could slow down bond redemptions in the short term and thus reduce the portfolio's ultimate residual amount.

Mr. Barnes moved to approve the contribution to the CHESLA Refi CT Program that was seconded by Ms. Savino. The motion passed unanimously.

#### IV. Adjournment

Mr. Hill made a motion, which was seconded by Mr. Barnes, to adjourn the meeting.

The motion passed unanimously, and the meeting was adjourned at 10:57 a.m.
